**Bids must be accompanied by bid security viz: Earnest Money (CDR/FDR), Additional Performance Security, (CDR/FDR), if any, and Treasury Receipt as cost of Tender Document to be pledged in favour of the Executive Engineer RWS Division Ganderbal (Under M.H 0215) (as specified in the table (I) (Page 1<sup>st</sup>).** Bid security will have to be in any one of the forms as specified in the bidding documents and shall be valid for six months after opening of bid. ***Bids will be opened in the Office of the Executive Engineer PHE RWS Division Ganderbal / Sgr (H.Q. Cheki Duderhama Ganderbal) on 31.12.2018 at 12:00 Noon.*** If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.

**i) GENERAL CONDITIONS OF THE CONTRACT**

:-

01) Bidders are advised to download bid submission manual from the “Downloads” option as well as from “Bidders Manual Kit” on website [www.jktenders.gov.in](http://www.jktenders.gov.in)

- 02) In the case the bidder uploads the bid with respective below percentages than the advertised cost, additional performance security in the shape of CDR/FDR shall have to be uploaded alongwith the online bid by the bidder.

**For contract Value Performance security**

Upto 15% below the advertised cost	2%
Beyond 15% to 20% below the advertised cost	5%
Beyond 20% to 25% below the advertised cost	10%
Beyond 25% to 30% below the advertised cost	15%
Beyond 30% below the advertised cost	20%

For successful bidder, the performance security deposited shall be released after successful completion of work. However, in case of failure to upload the addition performance security alongwith the bid, the tender shall be considered as invalid and rejected.

- 03) The earnest money shall be forfeited if:

- Any Bidder / tenderer withdraw his bid / tender during the period of bid validity or makes any modification in the terms and conditions of the bid.
- Failure of successful bidder to execute the agreement within 21 days after fixation of contract.

- 04) The department will not be responsible for delay in online submission in any reasons.

- 05) The following detailed instruments in shape of original and Scanned/ Photostat copies in separate envelopes *for each work* be submitted by the successful bidder to the Tender Receiving Authority i.e. Office of the Executive Engineer PHE RWS Division Ganderbal / Sgr (H.Q. Cheki Duderhama Ganderbal) in person or by Registered Post / Courier within 04 days after opening of the bid online, failing which the CDR/FDR and additional security deposit (if any) shall be forfeited without any correspondence in this regard, besides the bidder shall be debarred from participating in tendering process for one year which may be noted.

- 06) Bidders are advised not to make any change in BOQ contents. In no case they should attempt to create similar BOQ manually. The BOQ downloaded should be used for filling the item rate inclusive of all taxes and it should be saved with same name as it contains.
- 07) The unit rates and prices shall be quoted by the bidder entire in “Indian Rupees” and the rates quoted shall be deemed to include price escalation and all taxes upto completion of work unless otherwise specified. Deduction on account of taxes shall be made from the bills of the contractor on gross amount of the bill as per the rates prevailing at the time of recovery.
- 08) All the bidders have to produce valid GST Registration No. and PAN No.
- 09) The bidder at his own responsibility and risk should visit and examine the site of work and its surroundings before submission of bid.

- 10) All documents relating to the bid shall be in the English language only.
- 11) If the bidder does not quote for any item of the rate list / quantity schedule, cost of such item / items shall be deemed to be part of the overall / total contract value. No rate shall be allowed for such item / items in the allotment of the contract.
- 12) The date of start of the work shall be reckoned within one week from the date of issuance of LOI / contract allotment as the case may be.
- 13) In case of delay in completion of work beyond stipulated period of completion, penalty upto maximum @ 10% of the contract shall be imposed. However, suitable time extension shall be granted in case of increase in scope of work or in the event of delay beyond control of contractor to be determined by the department.
- 14) The tender/ bid is liable for rejection if it does not fulfil the requirements as laid down in the NIT.
- 15) The bids shall be valid for a period of 180 days reckoned from the date of opening of bids.
- 16) The tender receiving authority reserved the right to accept or reject any tender or all the tenders without assigning any reason thereof.

All other terms and conditions shall be the same as are laid down in PWD Form 25 / 33 double agreement form.

- c) The bidders have to submit their bids online in electronic format with Digital Signature. The bids cannot be uploaded without Digital Signature and no proposal will be accepted in physical form.
- d) Bids will be opened online on 31.12.2018 at 12:00 Noon.
- e) Before submission of online bids, bidders must ensure that scanned copy of all the necessary documents have been attached with Bid. Details of documents required is available along with downloadable tender documents on <http://jktenders.gov.in>.
- f) The department will not be responsible for delay in online submission of bids whatsoever reasons may be.
- g) All the required information for bid must be filled and submitted online.
